- (ii) That the society/trust is eligible as per the clause 4 of the NCTE Regulation, 2009. (specify the category of the institution as per provisions of the NCTE Regulations, 2009)
- (iii) That the institution is in possession of legally valid land documents and conversion of land has been obtained from the competent authority as per the provision of the law of the concerned State.
